To support twin goals of strengthening the psychotherapy workforce and strengthening the psychotherapy evidence base.

To contribute to the development and implementation of UKCP's research and policy strategy, including providing research support for campaigning to policymakers.

### Main duties and responsibilities:

- To assist the policy and research manager and wider campaigns team in their ongoing national policy and campaigning work, such as raising awareness of psychotherapy and improving access to psychotherapy.
- Supporting all aspects of policy, campaigning and public affairs work including MP engagement, campaign design and administration.
- Leading on UKCP's devolved policy engagement work in Scotland, Wales and Northern Ireland.
- Building relationships with stakeholders within parliament, public bodies, higher education institutions and the wider mental health sector.
- Contribute to work to lobby Government, NHS England, local commissioners and other decision makers and stakeholders.
- Undertake desk-based research to support policy objectives, such as literature reviews and scoping research.
- To support appropriate research projects, including collecting and analysing survey data.
- Provide administrative support to the organisation's research committees.
- To assist in the organisation's advocacy work on behalf of members, and services where members work, under the supervision of the policy and research manager.
- Contribute to social media and blogs on the website, when relevant to specific policy and research work.
- Produce written briefings, publications and other materials that communicate complex messages clearly and effectively to different audiences.
- To provide policy and research input to support the delivery of the UKCP strategy.

This is not an exhaustive list and you are required to be flexible in your approach to carrying out your duties which may change from time to time to reflect changes in UKCP's approach to a culture of continuous improvement.

- Ability to engage and build positive relationships, including with colleagues from other organisations across the sector, and with higher profile stakeholders such as MPs and policy makers.
- Ability to propose and manage projects independently, as well as work as part of a team to deliver pre-determined objectives.
- Excellent ability to plan and prioritise multiple projects to meet agreed deadlines and targets, and ability to respond to tight deadlines and changing circumstances.
- Commitment to equity, diversity and inclusion and ability to put this into practice.

- A master's degree in a relevant social science subject such as politics, psychology, or social policy.
- An understanding of national and local NHS structures, and an overview of current issues facing the public provision of psychological therapy.
- Experiencing of conducting qualitative research.
- Experience using data analysis software, such as STATA or R.

- Experience of local campaigning.
- Experience of engaging service-users in the policy and campaigns process.
- An awareness of current issues in mental health and appropriate language.
- Knowledge of devolved policymaking processes in any of the four nations.
