I declare that I:

- meet the terms and conditions for UKCP full clinical membership with the pre-retirement add-on which I am applying for or renewing.
- > am currently engaged in clinical practice.
- > remain a member of my college and, if applicable, organisational member.
- am winding down my clinical practice and will cease practicing within two years of registering for the pre-retirement add-on.
- understand that if I change my mind about retiring, I will inform UKCP to have the preretirement add-on removed from my membership and I agree to pay the difference between the pre-retirement add-on fee and the full membership fee without the add-on covering my time since registering for the add-on plus a reinstatement fee of £50.
- have appropriate current and ongoing professional indemnity insurance to cover my area(s) of practice.
- have read UKCP's Code of Ethics and Professional Practice.
- agree to abide by the UKCP's ethical framework, including but not limited to UKCP's Code of Ethics and Professional Practice, complaints and conduct process and codes and policies issued by the UKCP college and, if applicable, organisational member through which I am registered.
- do not work with clients when unable to do so for physical or mental health reasons, or when impaired by the effects of drugs, alcohol or medication.
- will inform UKCP and my UKCP college/organisational member as appropriate of any periods where I am taking a break from clinical practice.
