The income generation specialist will play a pivotal role in exploring and developing new nonmembership income generation streams for UKCP. The successful candidate will carry out feasibility assessments, market research and business planning for various income-generating initiatives. They will help us diversify our income, contributing to the strategic aims and longterm financial sustainability of the organisation.

### Aims

To conduct feasibility assessments, market research and business planning to identify viable non-membership income-generating initiatives, while ensuring that these initiatives align with UKCP's strategic goals and consider the needs and interests of our members and the public.

# Main duties and responsibilities

Market research and analysis:

- Conduct desktop market research to explore potential new income generation opportunities.
- Identify trends, gaps and opportunities in the market that align with UKCP's strategic

goals.

- Benchmark against comparable organisations in the sector.
- Identify and analyse potential customer segments, understanding their needs and behaviours.

Feasibility studies:

- Assess the feasibility of proposed income generation initiatives, including financial viability, operational capacity and market demand.
- Evaluate risks, barriers and challenges for each potential initiative.
- Conduct financial modelling and cost-benefit analyses to determine potential revenue and investment requirements.

Proposal development:

- Develop comprehensive proposals for each income generation idea.
- Ensure that each proposal includes financial projections, encompassing whole life costs such as development, overheads and wind-down costs, along with risk assessments, stakeholder analysis, operational feasibility analysis and a focus on long-term sustainability.
- Prepare detailed reports and recommendations for senior leadership and the finance, risk and audit committee.

Strategic fit and integration:

- Assess how each income generation idea fits into UKCP's overall strategy and mission.
- Ensure alignment with the organisation's goals, including our commitment to improving services for members, EDI-BIIDE and enhancing our charitable aims.

Project management:

- Manage the scoping and development of income generation ideas from concept to the feasibility stage.
- Liaise with key internal and external stakeholders as needed.

Legal and regulatory considerations:

- Ensure that all proposed initiatives comply with relevant legal, regulatory, charity status and tax requirements.
- Investigate and adhere to any necessary accreditation (eg Fundraising Regulator accreditation for donation-related projects).

Reporting and evaluation:

- Prepare and present regular updates to the senior management team.
- Deliver final feasibility studies at the end of the contract, including clear recommendations on which initiatives should be taken forward.
